Draft minutes of APDF Ex. Co. meeting:

Judy welcomed all who attended the meeting.

1 . APDF GA and Conference in 2008

Mr. Hye Howlader, Secretary of Ministry of Social Welfare expressed his appreciation for the APDF meetings in Dhaka to be organized this February, and indicated that the Bangladesh Government would provide its strong support for the success of the conference. He also indicated that he expected many participants from overseas.

Mr. Alam Khandakar, President of the National Forum Working with the Disabled (NFWOD) of Bangladesh explained the preparation of the APDF General Assembly and Conference to be held in Dhaka in Dhaka based on its first announcement.

The followings were confirmed.

- -Theme: Disability and Development Practical Strategies
- -Date: Feb 5 7. 2008
- -Venue: Bangladesh China Friendship Conference Center (BCFCC), which is accessible. One room for the plenary session and 4 rooms, which could be used for 5 sectoral sessions, are reserved for the Conference.
- -For accommodations, guest houses are available, which cost about US\$30-35 per person per night. There are several accessible guest houses.
- -Expected number of the participants is about 500, including 200 from overseas.
- -APDF Ex Co meeting will be held either in the same venue or in one of the guest houses, which has internet accessibility, in the late afternoon of Feb. 4, 2008.
- -APDF General Assembly will be organized from 4:00 to 6:30 on Feb. 5.
- -Registration fee is US\$100 for participants from Asia and the Pacific. Payment of registration fee needs to be made through the bank transfer or on arrival. Credit card is not acceptable.
- -The International Airport is accessible.

Issues to be confirmed are as follows.

-Communication services:

The organizing committee is to ask a relevant Indian organization for its cooperation to provide American sign- language interpreters for the Conference.

-Keynote speaker

Prof. Yunus, President of Gramin Bank was originally considered to be a keynote speaker, however, as he is going to establish a political party, he will no more suitable for it. Therefore, the organizing committee is now looking for another appropriate keynote speaker.

-Side event:

The World Bank may be interested in organizing a special program on disability inclusive development in conjunction with the APDF Conference.

ICECV also shows an interest in organizing a program.

Other organizations, which are interested in organizing side events, should make a contact with Mr. Nafees Rahman, secretariat of the Organizing Committee.(E-mail: nfowd@bdmail.net)

-APDF secretariat is to request ESCAP support to the APDF meetings by making use of its logo as well as sending a representative to the Conference to address its opening ceremony to provide APDF with its strong moral.

-Simultaneous interpretation booth is available with the extra cost. Its cost will be informed later.

-APDF members are expected to promote participation from the region through information provision

2. Activities of APDF

2-1 Mr. Tue explained about the International Exchange Program with the theme of Friendship, Cooperation, Equity, Integration to be organized in Hanoi from June 8 to 11, 2007. This is an exchange program among people with disabilities of 4 countries (Korea, Japan, the Philippines and Vietnam) Participants from other countries are also welcome. An APDF representative is expected to attend at its opening ceremony to give an address.

The registration fee is US\$515 which includes accommodation, dinners, lunches, field visits(villages and Harlong Bay)

The details will be announced in the website of NCCD this April, which will be linked with the website of APDF.

Mr. Joseph Kwok asked about a possibility of organizing the joint committee meeting of the Information Working Committee and the Accessible Tourism Working Committee in conjunction with the Exchange program in Hanoi this June.

This will be followed up with Mr. Tue by the secretariat.

Mr. Joseph Kwok will take part in the program, representing APDF, and make an address at its opening ceremony as requested.

- 2-2 Topong also explained am Accessible Tourism Conference to be organized in Bangkok toward the end of November or early December 2007 as a second event of the Accessible Conference held in Taipei in 2005. Topong indicated that the City of Bangkok agreed to host this conference. Joseph suggested the involvement of the Accessible Tourism Committee chaired by Mr. Robert Lin.
- 3. Relationship with IDA (International Disability Alliance)

Judy reported the result of the telephone conference among IDA members which are DPI, IFHOH, II, RI, WBU, WFD, WDDB and WNUSP. IDA is now considering to expand its membership to regional structures. European Disability Forum (EDF) already expressed their interest in becoming its member. APDF was asked to consider to join IDA.

After lengthy discussions on the pro-cons to become a member of IDA it is agreed to inform IDA that APDF is interested in becoming its member as APDF has nothing to lose to be its member.

4. APDF Conference in 2010

Mr. Tue proposed to organize the APDF Conference in Hue in 2010. He was asked to decide its schedule and inform Ex Co members.

5. Collaboration with UNESCAP and other relevant international agencies In order to have closer collaboration with the ESCAP in regard to the promotion of BMF and BMF plus Five (to be adopted at the High-level Intergovernmental meeting to be held at the ESCAP Headquarters this September), the following possibilities are discussed.

5-1 Possibility of a joint program with UNESCAP in September, 2007

UN ESCAP organizes the High Level Intergovernmental Meeting in Bangkok from September 19 to 21, 2007.

5-2 Possibility of a joint program in relation to GPDD in the APDF Conference in Feb. 2008. According to Ms. Akiyama, the World Bank also showed its interest in identifying an entering point of GPDD(Global Partnership for Disability and Development) at its meeting held in India last month. It might be an excellent opportunity to organize a joint program on GPDD in Dhaka on the occasion of the APDF Conference next February. However, it seems that it might take some time for its making a concrete action.

6. Information from APCD

Ms. Ninomiya mentioned that APCD was going to send a mission to the Central Asian countries for the purpose of looking into a possibility of expanding APCD target countries to the Central Asia as its second phase activities.

The meeting was adjourned at 20:00pm.
